**Keys Gate Charter School Parent Contract**

I (We) the parent(s)/guardians of \_\_\_\_\_, grade \_\_\_\_\_ have read and agree to abide by the Code of Conduct and the Dress Code of the KEYS GATE CHARTER SCHOOL.

**WHEREAS**, in order to provide my (our) child with a unique educational opportunity;

**WHEREAS**, by choosing to enroll my (our) child at the Keys Gate Charter School is a decision of my (our) personal choice and not a privilege;

**WHEREAS**, my (our) desire to enroll my (our) child at the Keys Gate Charter School is premised upon my (our) desire to become an **active partner in the education** of my (our) child;

**NOW THEREFORE**; in consideration of the foregoing:

1. As a parent of a student at the Keys Gate Charter School, my (our) commitment is to abide by the following resolutions:
  - a. To recognize and embrace my role as the primary educator of my child.
  - b. To ensure that my child meets his/her academic responsibilities throughout the school year as indicated in the **Error! Reference source not found.** Parent Handbook.
  - c. To attend all conferences scheduled with any member of the Keys Gate Charter School staff.
  - d. To participate in the Parent Service Program, including 20 hours of service or more based on enrollment, at the rate that is sensitive to the needs of the school. Half of the hours must be completed by the last school day prior to winter recess, followed by the final hours due by May 15<sup>th</sup>.
  - e. To provide transportation to and from school for my child. I understand that if I am late picking up my child, Keys Gate Charter School is not responsible for my child's safety. If my child is continually tardy, absent or dismissed early, I understand that for the benefit of my child's education, he/she may be required to transfer to a school that is more accessible for my child.
  - f. To purchase uniforms for my child from the Keys Gate Charter School approved supplier.
  - g. To supply my child with a nutritious lunch, either brown bagged or purchased from the Keys Gate Charter School approved vendor, each school day for my child.
  - h. To be responsible for timely payment of any fees accrued to my account at the Keys Gate Charter School. To participate in at least one of the many parent groups (i.e. PTSO, School Improvement Committee, Booster Clubs, etc.).
  - i. To ensure that my child exhibits appropriate behavior while in school campus as indicated in the **Error! Reference source not found.** Handbook.
  - j. To read and use information sent home by the school or via Keys Gate Charter School website for the purpose of keeping parents informed of the academic topics to be introduced and studied in the classroom and/or important notices and information pertaining to the school.
  - k. To strongly consider obtaining PTSO membership, and attend a minimum of 2 PTSO meetings per school year.

I (We) understand that by not fulfilling my contractual obligations to the school and to my (our) child as indicated above and in the KGCS Parent Handbook, this may result in my (our) child requested to stay after school, be suspended, lose the opportunity to recommit for placement for the following school year or withdrawn and sent to a regular public school at the sole discretion of the Principal as approved by the Keys Gate Charter School Governing Board.
